#### What Information We Collect and Maintain

We may collect the following types of "nonpublic personal information" about you:

- Information from our initial meeting or subsequent consultations about your identity, such as your name, address, social security number, date of birth, and financial information.
- Information that we generate to service your financial needs.
- Information that we may receive from third parties with respect to your financial profile.

#### What Information We Disclose

We are permitted by law to disclose nonpublic information about you to unaffiliated third parties in certain circumstances. For example, for us to provide planning or investment management services to you, we may disclose your personal information in limited circumstances to various service providers, such as our clearing firm or independent contractors hired by Pulse Financial Planning.

Otherwise, Pulse Financial Planning will not disclose any personal information about you or your account(s) unless one of the following conditions is met:

- We receive your prior written consent
- We have documentation that the recipient is your authorized representative
- The business succession plan is triggered due to death or incapacity of key personnel
- We are required by law to disclose information to the recipient
